School-Based Food Pantries in Community Schools

Karmin Williams, Director, Community Schools

The Community Schools strategy offers a transformative solution to the systemic challenges facing public education. By addressing education inequities through six key practices, the model reimagines schools as hyper local community hubs that coordinate resources, collaborate to increase opportunity, and reflect the unique strengths of each neighborhood and community.

- Distributive leadership & stakeholder voice
- Integrated Supports, including Basic Needs
- Food Pantries were identified as a primary need based on the Needs Assessment

Option 1: 20 schools x \$15,000 for pantry set up, garden set up, planning + \$50,000 ready cooked meals for unhoused individuals = \$350,000.

\$15,000 for the year, per school will equate to approximately \$1,500 a month. Schools will determine how to supplement current food supply partners' inventory with needs expressed by the community, as well as support garden infrastructure and support.

Option 2: 20 schools x \$10,000 to supplement pantry inventory, support partnerships with organizations, maintain and continue garden programs, obtain supplies for cooking classes, procure gift cards to incentivize community and family participation in running/supporting + \$50,000 ready cooked meals for unhoused individuals = \$250,000.

Educational Assistants (EA)

Average Base Salary: \$51,180
(.875 FTE)

Fringe Rate: 33.06% = \$16,920

Health Ins Avg: \$20,055

Avg Cost/Year= \$88,155

Avg 6% increase per year for
Step/COLA for future planning

*This means \$1 million investment could cover approximately **11 EAs in 2025-26 School Year**. Each EA could either be assigned at one or two schools.*

Budget cuts mean many EA's will be unassigned for FY26, and staff with seniority will be reassigned if new positions are added.

Educational Assistants

Districtwide Costs

- *To add 83 FTE (.875) Educational Assistant to each school would cost $\$88,155 \times 83 =$ **\$7,316,865***
- *To add 42 FTE (.875) Educational Assistants to split their time between two schools would cost $\$88,155 \times 42 =$ **\$3,702,510***
- *It is challenging to have regular employees paid from unstable sources of funding. There are labor agreements and labor rules that will need to be considered.*

When we talk about 83 schools that includes some of large alternative schools (e.g. Alliance, MLC), but it does not include all of the smaller alternative and independent schools that are also part of PPS. Therefore, another \$1,000,000 could be used a allocated based on the number of PPS students that attend these programs.
