Regional School Foundations Supporting School Districts in the Pacific Northwest

Hillsboro, Beaverton, North Clackamas, Lake Oswego, Vancouver, Seattle

- In general, smaller grants for classroom projects or district programs, not FTE
- Lake Oswego allows fundraising for FTE in a one pot model
- Two groups in Seattle and only Alliance for Education allows funding FTE and allocated by program

"This policy is designed to foster a spirit of community and shared purpose and facilitate collective impact on behalf of PPS students. Given our common mission and vision, the District encourages parents and community groups to advocate, fundraise and support improving the educational experience districtwide in alignment with our racial equity and social justice values."

Community Budget Review Committee

The purpose of the PAC should not be confused with the CBRC.

Parent fundraising will not be enough to reduce class sizes, student-to-counselor ratios or replace positions cut by budget reductions.

The Community Budget Review Committee (CBRC) reviews, evaluates, and makes recommendations to the PPS Board of Directors regarding the Superintendent's Proposed Budget and any other budgetary issues the CBRC or the Board identify. The CBRC also reviews the allocation and expenditure of Local Option Levy funds. The CBRC generally meets monthly during budget development season, November through June, with additional meetings scheduled as needed.
